

# NOTICE

## **SPECIAL ACCESS AND ADMISSION COMPETITION FOR INTERNATIONAL STUDENTS – NURSING (1ST CYCLE)**

**School year 2025/2026**

Escola Superior de Enfermagem de S. José de Cluny sets 2 vacancies for the Special Access and Admission Competition for International Students in the academic year 2025/2026 for the Nursing Course (1st cycle), according to Decree-Law No. 36/2014 of March 10, amended and republished by Decree-Law No. 62/2018 of August 6, as set out in its Regulation No. 4/2021, of January 5.

### **1. Recipients**

- 1.1. Students who do not have Portuguese nationality;
- 1.2. Those who meet the conditions described in paragraph 2 of article 2 of Regulation no. 4/2021, of January 5, are not covered by the previous number.

### **2. Access and admission conditions**

2.1. Established in chapter I, art. 3, of Decree-Law no. 36/2014, of March 10, republished in Decree-Law no. 62/2018, of August 6, and by the regulations of the Special Access Competition for International Students;

2.2. The following can apply for enrollment and registration for the Bachelor's Degree in Nursing:

- a) Holders of an academic qualification that, in the country where it was obtained, gives access to Higher Education in that country, the validation of which must be carried out by the competent entity of that same country;
- b) Holders of a Portuguese secondary education diploma or legally equivalent qualification, in accordance with Order No. 224/2006, of March 8, and Order No. 699/2006, of July 12.

2.3. The following are conditions for admission to the 1st Cycle of the Nursing Degree Course:

- a) Verification of the specific academic qualification for admission into the study cycle, in accordance with Article 5 of Regulation No. 4/2021 of January 5;
- b) Verification of the prerequisites established for access to the 1st Cycle of the Nursing Degree Course (Group A):
  - a) *Interpersonal Communication:*  
Absence of psychological, sensory, or motor deficiency that seriously interferes with functional capacity and interpersonal communication to the point of preventing one's own or others' learning.
  - b) *Form of proof:*  
Medical certificate, in the form of a response to a questionnaire, in accordance with the regulations published as Annex III to Resolution No. 202/2012 of 16 February;
- c) Knowledge of the Portuguese language, proven in accordance with Article 6 of Regulation No. 4/2021, of 5 January.

## **5. Selection and ranking criteria**

5.1. The jury will assess all the documentation submitted, in accordance with points 2 and 3 of this Notice, and will draw up a list, ordered alphabetically, with one of the following mentions, in accordance with Regulation No. 434/2014, of 10 October, of the ESESJC:

- a) Admitted;
- b) Conditionally admitted;
- c) Excluded.

5.2. The final placement list is presented in descending order of final classification, which corresponds to:

- a) The simple arithmetic average of the grades obtained in the Portuguese or equivalent entrance exams;
- b) The final classification of the grades obtained in the higher education access exams taken in higher education in the country of origin;
- c) The final classification obtained in the exams taken at ESESJC.

5.3. The final results of the competition are made public, in accordance with the previous paragraph, containing one of the following mentions, in accordance with Regulation No. 434/2014, of October 10, of ESESJC:

- a) Placed;
- b) Not placed;
- c) Deleted.

## **6. Complaints**

Candidates have a period of 5 working days to submit complaints after the results have been published. Complaints must be addressed to the chairman of the selection board.

## **7. Tuition and other fees**

The exams require a fee of 65 euros for each exam to be taken, to be paid at the time of registration. The written and oral components make up a single exam. The exams are only intended for international students who intend to apply to ESESJC and cannot be used for applications to other institutions.

Applying via the special access and admission competition for international students cost 90 euros.

The tuition fee is 5,555.00 euros per year, paid in 11 monthly instalments of 505.00 euros (from September to July).

Enrolment costs 130 euros (to be paid in the first year of the course).

Semester enrolment has an associated fee of 50 euros.

The first monthly payment of each academic year is increased by 8 euros, corresponding to the annual student insurance.
